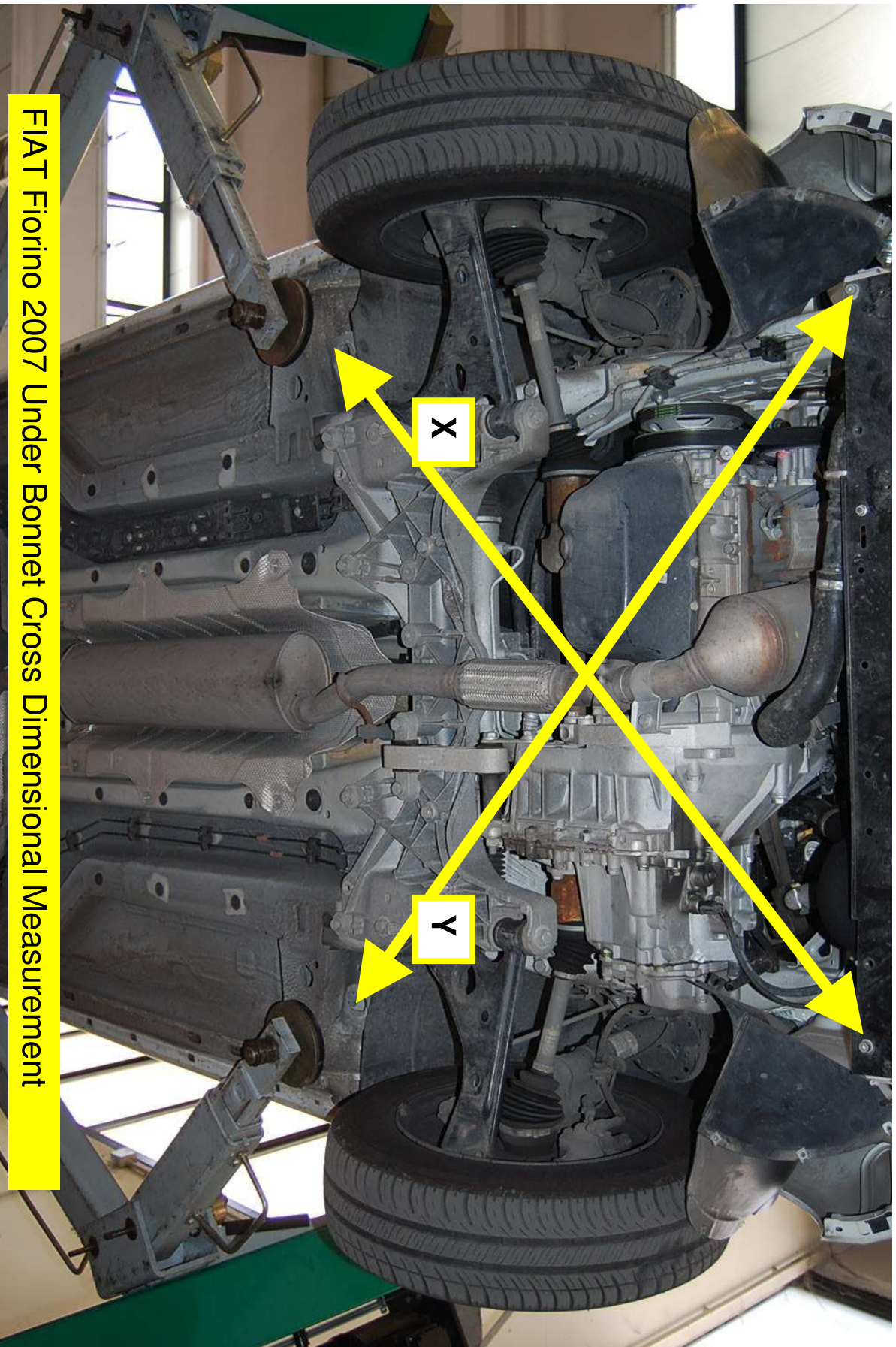

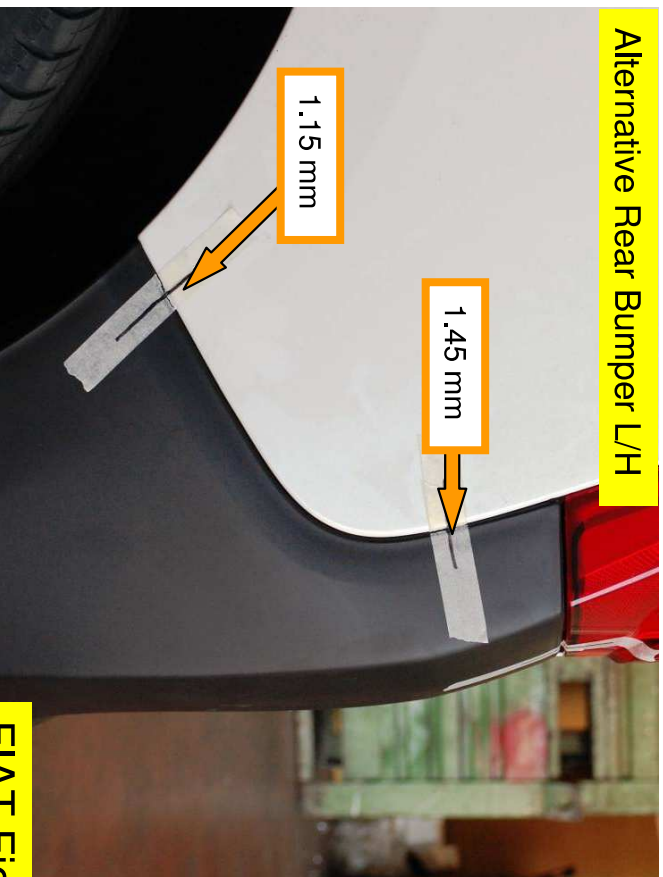

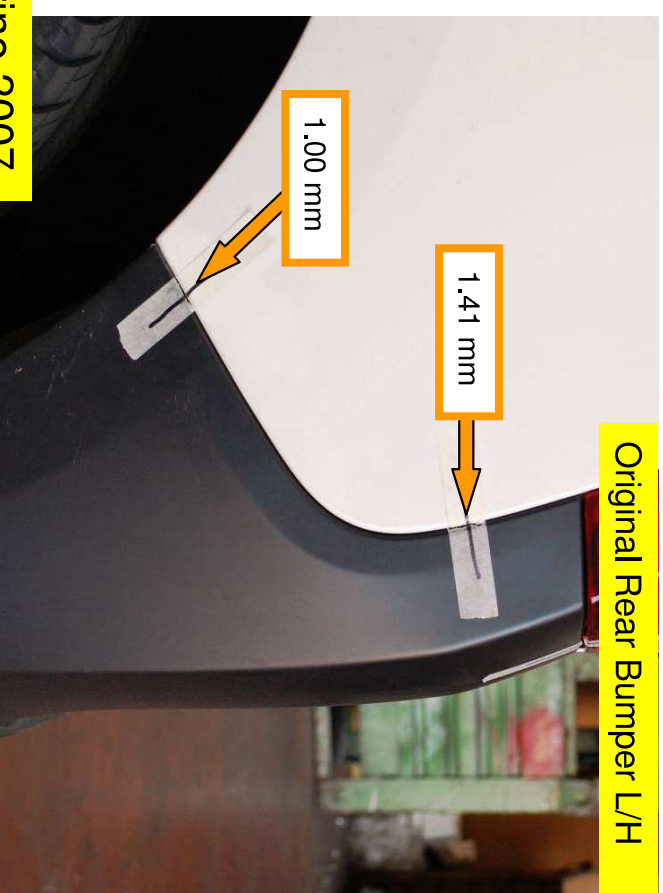
FIAT Fiorino 2007 Spmp Rear Bumper Fitted

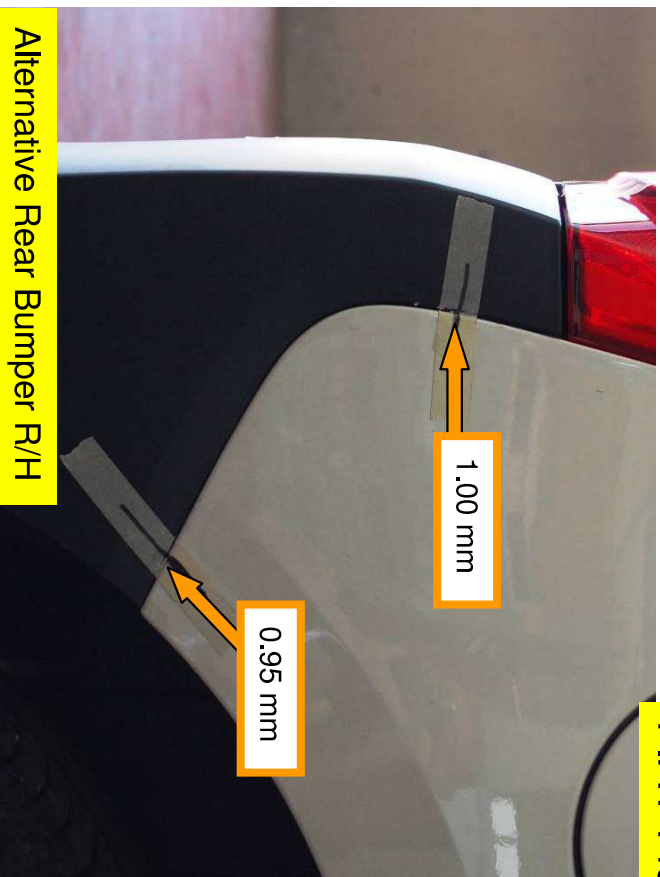


Original Rear Bumper L/H

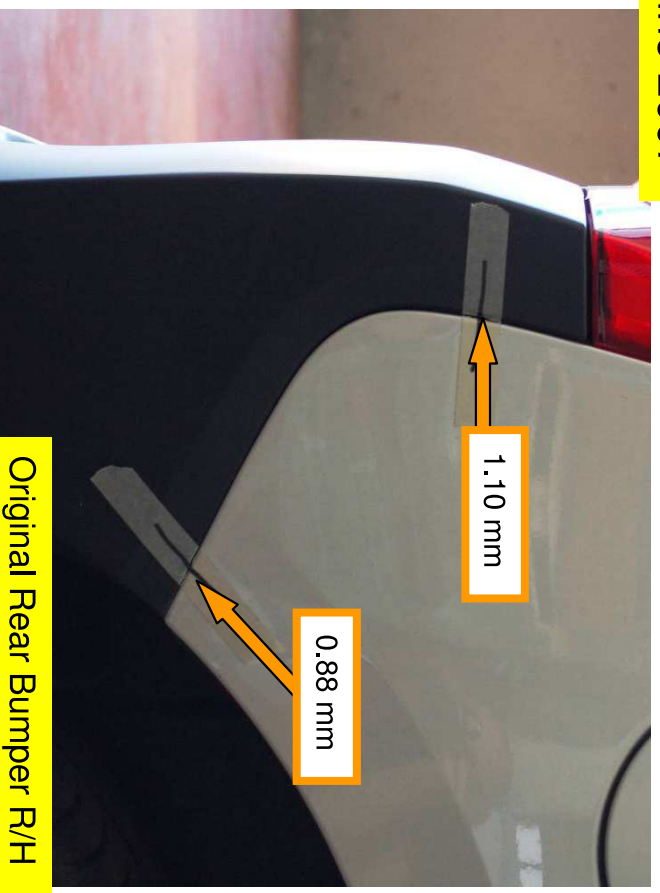

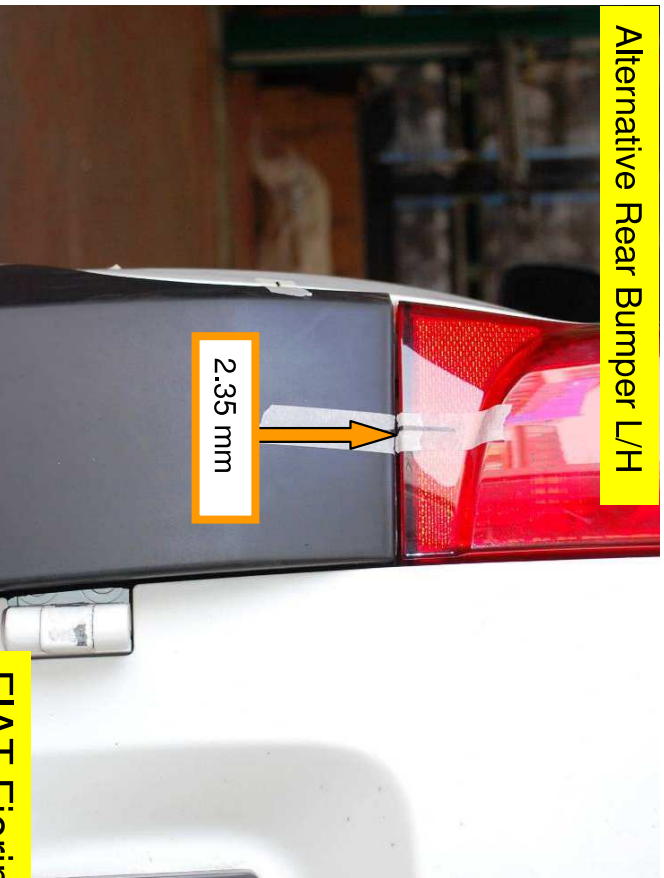
Alternative Rear Bumper R/H



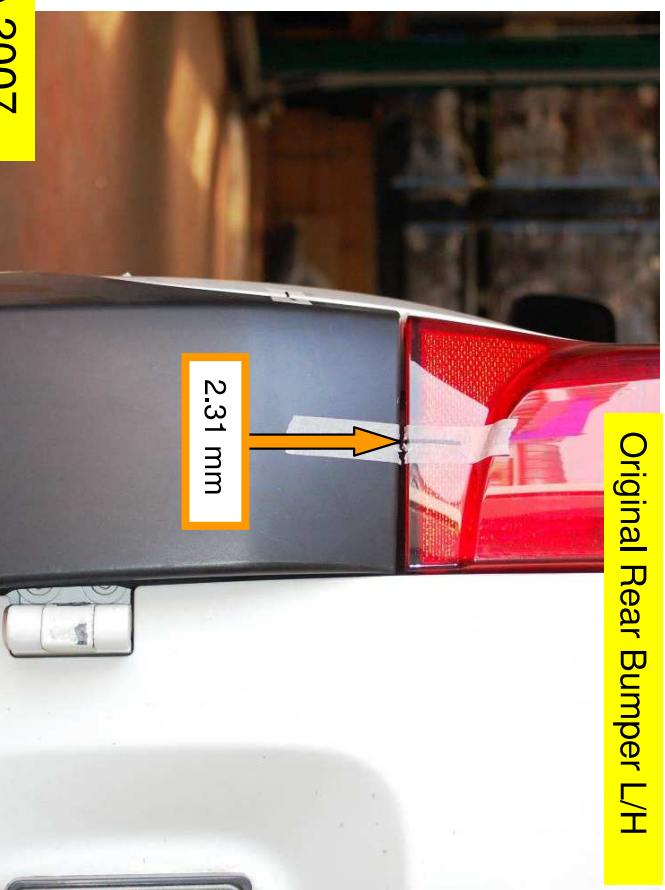
