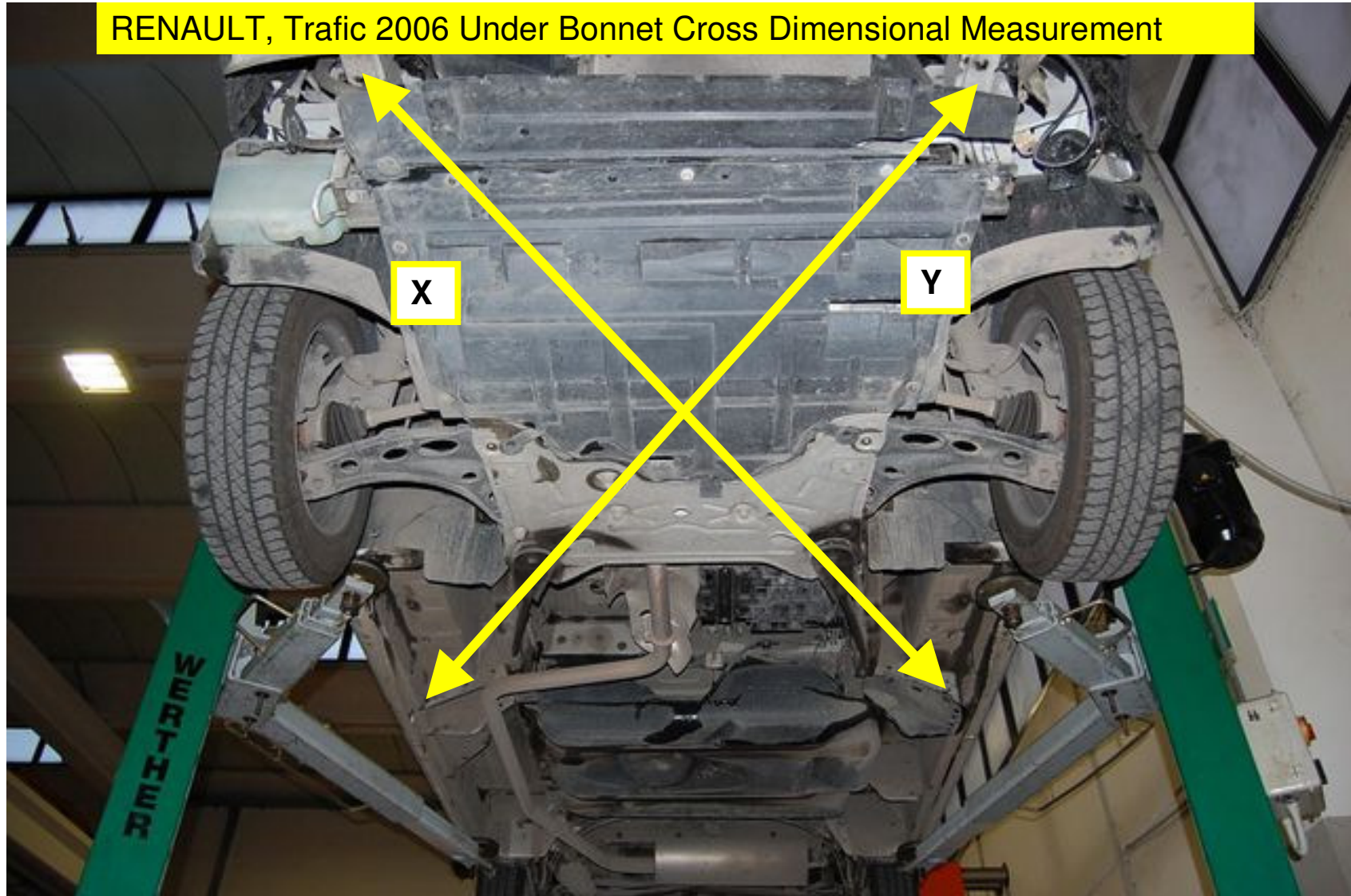

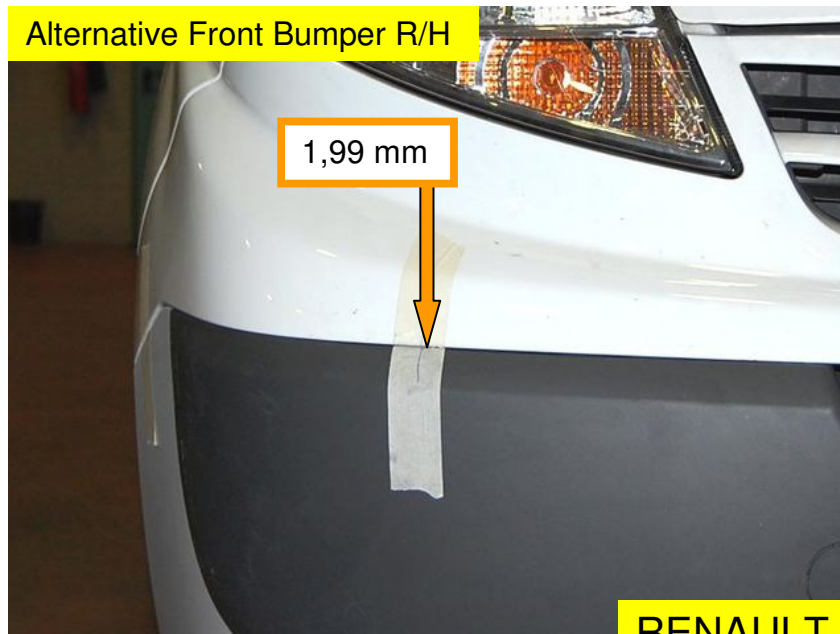

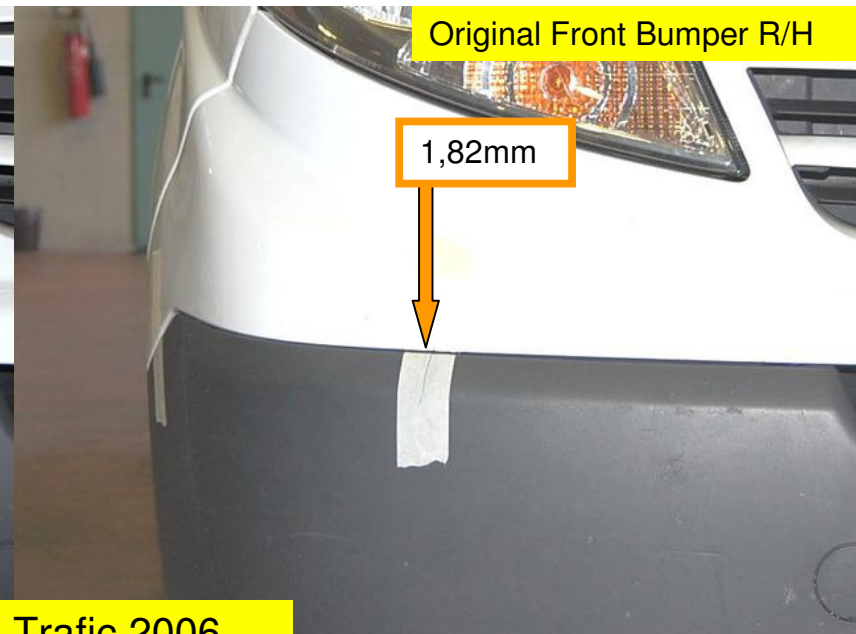




Alternative Front Bumper R/H

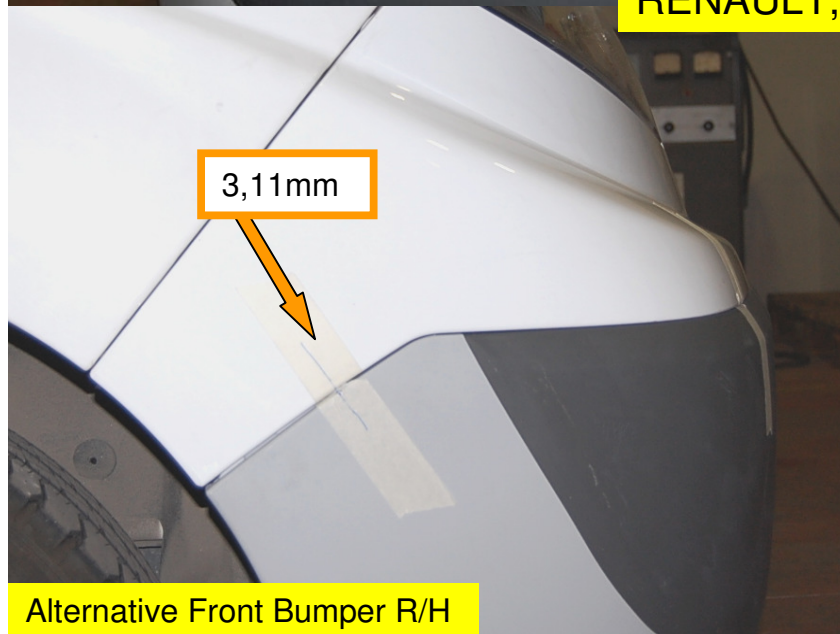


Original Front Bumper R/H

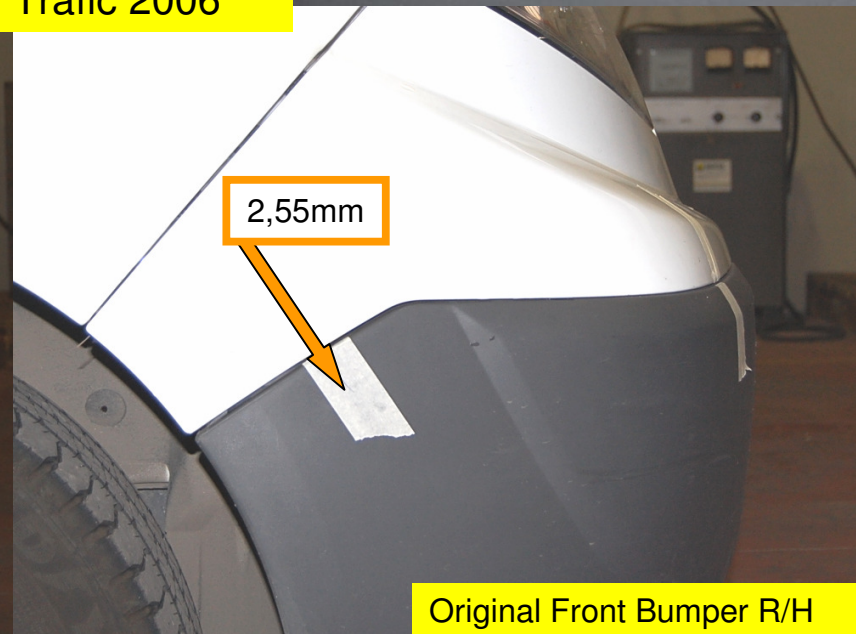

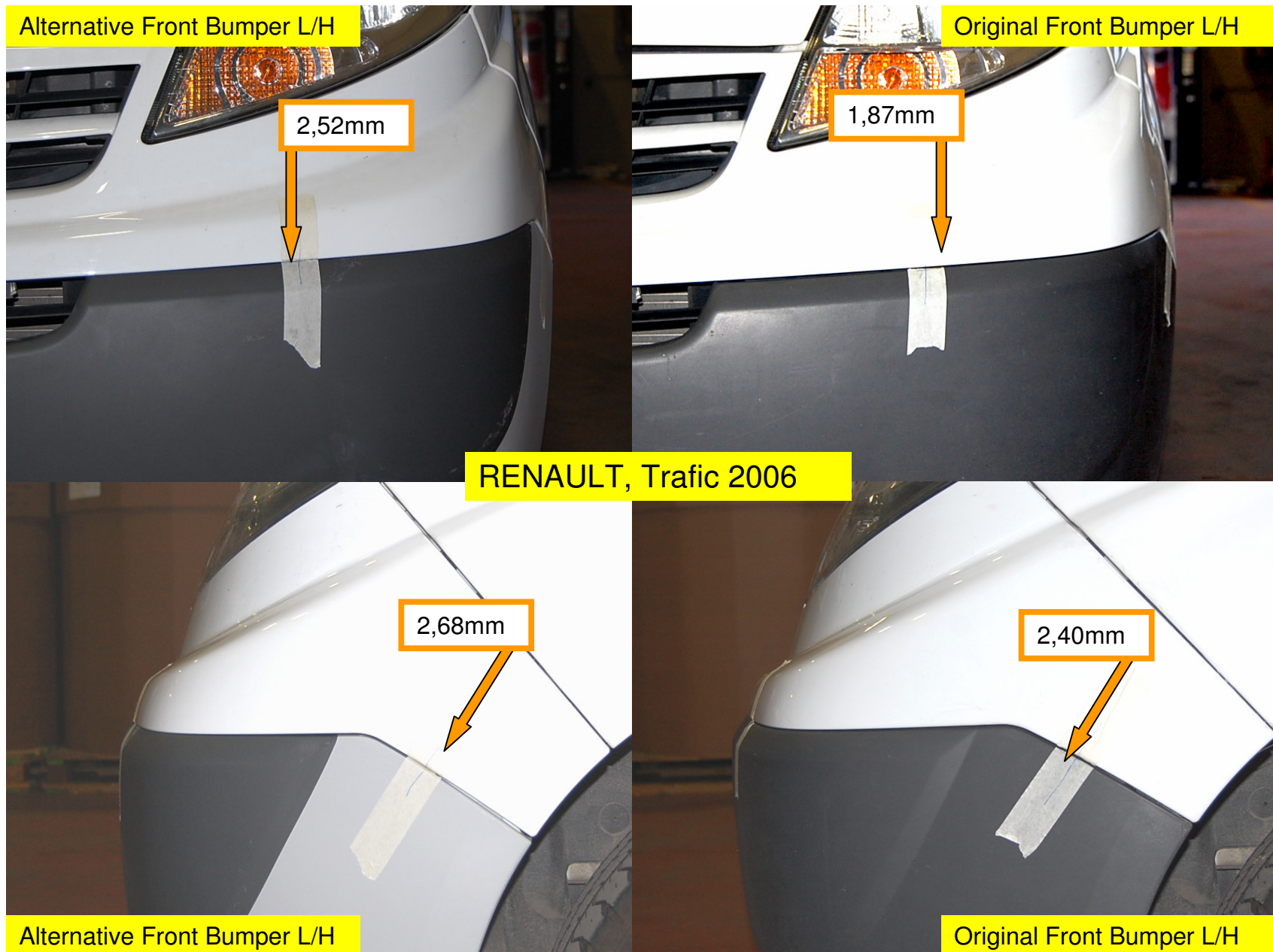
